### **PURPOSE:**

The purpose of this report is to report on the expenses of the Board of Directors, the President and Chief Executive Officer (“President and CEO”), and certain Toronto Community Housing Corporation (“TCHC”) employees for the 2021 Year.

### **RECOMMENDATION:**

It is recommended that the BIFAC receive this report for information.

### **REASONS FOR RECOMMENDATION:**

At its March 9, 2011 meeting Toronto City Council passed the following motion<sup>1</sup>:

*City Council request the Toronto Community Housing Corporation (TCHC) to immediately post on the TCHC website, all expense records*

*of all TCHC board members and all TCHC staff members whose salaries exceed \$100,000.*

Pursuant to this motion, reference to 'TCHC Employees' and/or 'Employees' in this report and in the public disclosure of employee expenses is defined as those employees whose annual salary exceeds \$100,000 per annum.

All expenses submitted by the President and CEO, and Directors are approved by the Chair of the Board of TCHC to ensure the expenses claimed are incurred in the performance of duties related to TCHC. The Chair's expenses are signed off by the President and CEO as a check and balance at the point of reimbursement.

Employee expenses are reimbursed pursuant to TCHC's *Expense Reimbursement Policy* and *Expense Reimbursement Procedures*. All Board of Directors, the President and CEO, and employee expenses will be posted on the TCHC website.
